## Recognition Order

Whereas in terms of Section 14(1) of the NCTE Act, 1993, District Institute Of Education and Training Bharuch, Plot No. 291/s, B/II Manan Ashram, Zadeshwar, Dist.Bharuch,(GJ) 392011, (Code No. WRCAPP1555) had submitted an application on 29.09,2011 to the Western Regional Committee of the NCTE for grant of recognition of D.EL.Ed. course with an annual intake of 50 seats.

And whereas, a deficiency letter dt. 12.01.2012 was issued to the institution to make good of deficiencies within 60 days.

And whereas, reply dt. 03.03.2012 submitted by the institute was considered by WRC in its 163rd toecting and decided to constitute an inspection team for causing inspection of the institution.

And whereas inspection of the institute was conducted on 21.07.2012.

And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, laboratory and that it fulfills such other conditions required for proper functioning of the institution for D.EL.Ed.course, as determined by clause 7(9) of NCTE Regulations, 2009, and decided to issue letter of intent dt. 27.08.2012.

And whereas, reply dt. 09.11.2012 submitted by the institution was considered by WRC in its 176th meeting and committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, laboratory and that it fulfills such other conditions required for proper functioning of the institution for D.EL.Ed. course, as determined by NCTE Regulations 2009.

Now, therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition District Institute Of Education and Training Bharuch, Plot No 291A, B/H Manan Ashram, Zadeshwar, Dist.Bharuch,(GJ) 392011 (Code No. WRCAPP1555) for starting D.EL.Ed. course of Elementary level of 2 year duration with an annual intake of 50 from the academic Session 2013-14.

Further, the institution is required to comply with all post-recognition conditions enumerated from clause 8(11) to clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations 2009.

The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or hysolaws. it shall intimate in writing with documentary evidence of its inability to do so.

The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009 for the academic session

The recognition will operate for 2012-2013 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.
